Customer agrees that the charges for such repairs and cleaning will be assessed to the credit card for the individual or entity who has rented the Maybach. In the event that the credit card is not able to be charged, customer agrees to remit payment for damages within seven (7) days of the date of the event.

HOLD HARMLESS

Customer agrees to hold the driver and Vendor harmless for any and all negligence or gross negligence in the maintenance and operation of the Maybach. Customer agrees to indemnify the driver and Vendor for any and all costs and fees incurred in the defense of any claim made against them arising out of and in connection with the rental of the Maybach.

BREACH OF CONTRACT AND ATTORNEY FEES

If the customer shall breach this contract, the Vendor shall be entitled to terminate service under this agreement immediately and be entitled to his attorney's fees, the costs of collection and costs incurred in any lawsuits arising out of or in connection with said breach.

SEVERABILITY

If any provisions of this contract are deemed void or unenforceable, the remaining provisions shall remain in full force and effect.

JURISDICTION

The parties agree that all the terms and conditions stated herein shall be construed under the laws of the State of Maryland and any action or proceeding brought in connection with or arising out of this contract shall be within the jurisdiction of the Charles County Circuit Court or Charles County District.
